Examples of recent exhibitions include the annual "23rd International Open" juried by Juana Williams in Oct/Nov 2020 which highlighted masterful works from women artists around the world; "Reciprocity" juried by Barbara Cjurej and Lindsay Lochman in March 2021 explored the collaborative community and work practices of women artists working in photography; "Boundaries" juried by Whitney LaMora in April/May 2021 showcased the unique experiences of women as life has changed and presented new inequities due to COVID-19; "We Found Love" juried by Zakkiyyah Najeebah Dumas-O’Neal and Aliya Parashar in May/June 2021 will showcase LGBTQIA+ communities and the concepts of love in chosen family as against dominant heteronormative nuclear family structures. WMG features all exhibitions online at womanmade.org/exhibitions. Nearly 300 member artists are supported annually through the WMG network. Explanation: In April 2022, our organization's volunteer Treasurer completed the 990 form and provided that form to our then-Managing Director, Jamie Pitts. Jamie was instructed to complete one item where data was needed, and then to submit the form. To our knowledge, she never did so. On May 21, 2022, Ms. Pitts resigned without providing notice. She had neglected almost all of her administrative duties for the period of April and May. However, the Board was unaware of this fact until recently. We had been told by Jamie at a board meeting that the 990 form was filed. But since it is not shown on the IRS website and we have no copy of the final submitted file, we assume it was not filed. It took some time to gain access to her emails and review all outstanding issues. We are now filing this late but hope that the IRS will waive penalty fees as we made every effort to file as soon as we were made aware of the situation.
